**RESULTS FOR QUARTER ENDED 30 JUNE 2007**

During the quarter Eurogold Limited ("the Company") disposed of its Ukrainian gold mining assets to Resource Invest LLC ("RIL") pursuant to the Asset Sale Agreement dated 19 May 2007 and Shareholder approval received at the Company's General Meeting held on 10 July 2007.

The Company has received an initial payment of US\$2,000,000 from RIL and is entitled to receive a further US\$3,000,000 upon RIL meeting a key regulatory milestone relating to the advancement of the Saulyak Gold Project.

The Directors' are actively pursuing new opportunities for its Shareholders and will keep the market fully informed of any progress.
